Reference is made to certain NEPA Screening Reports listed on Exhibit A hereto (the "NEPA Reports") previously provided to the New York City Office of Technology and Innovation and the proposed Link5G sites reviewed in the NEPA Reports (the "Proposed Sites").

I, Robert Sokota, President for Wireless for CityBridge, LLC hereby certify that:

As set forth on page 3 of each of the NEPA Reports, the Proposed Sites are excluded from review under Section 106 of the National Historic Preservation Act (NHPA) of 1966 pursuant to the Nationwide Programmatic Agreement for Review of Effects on Historic Properties for Certain Undertakings executed by the Federal Communications Commission, the National Conference of State Historic Preservation Officers and the Advisory Council on Historic Preservation (NPA). Specifically, NPA Section III.E excludes undertakings where:

"Construction of a Facility in or within 50 feet of the outer boundary of a right-ofway designated by a Federal, State, local, or Tribal government for the location of communications Towers or above-ground utility transmission or distribution lines and associated structures and equipment and in active use for such purposes, provided:

1. The proposed Facility would not constitute a substantial increase in size, under elements 1–3 of the definition in the Collocation Agreement, over existing structures located in the right-of-way within the vicinity of the proposed Facility, and;

2. The proposed Facility would not be located within the boundaries of a Historic Property, as identified by the Applicant after a preliminary search of relevant records.

Proposed Facilities within this exclusion must complete the process of participation of Indian tribes and NHOs pursuant to Section IV of this Agreement. If as a result of this process the Applicant or the Commission identifies a Historic Property that may be affected, the Applicant must complete the Section 106 review process pursuant to this Agreement notwithstanding the exclusion."

CityBridge, LLC has therefore determined that the Proposed Sites meet the NPA's Section III.E exclusion.
